**Range Capacity:** 10 shooters per relay

Adult Competitors \$10.00

**Eligibility:**

GO-NH WB Teams	Any Junior NH Resident
CCF&G WB Teams	CCF&G and FB Junior Members Only
FB Jrs WB Team	CCF&G and FB Junior Members Only
CMP Qualifications	ANYONE 10 yrs of age or older

**Rifle/Ammo:** Any safe .22 cal rifle, rule 3.2 Juniors: Metallic Sights 3.7a  
Adults: Any Sights  
Any safe .22 cal rimfire ammo. Free ammo is available for Juniors

**Course of Fire:** CMP Prone Dewar Course (100 yards first)  
20 Shots prone at 100 yds on A-33 100-yd metric target, 20 min  
20 shots prone at 50 yds on A-51 50-meter reduced target, 20 min  
Whistler Boy Tryouts (in addition to the CMP prone score)  
10 shots standing at 50 yds on A-51 combined time...  
10 shots kneeling at 50 yds on A-51 ...of 40 minutes

**Coaching:** Permitted

**Awards:** 1<sup>st</sup> Place: 100rds practice ammo award for each Junior category  
CMP medals / bars for all Juniors  
Top 6 eligible Juniors will represent GO-NH at the 2013 National Matches  
Top remaining eligible Jrs will represent CCF&G and FB Jrs at the 13 NM

**Notice:** Whistler Boy competitors intending on going to the National Matches  
Sponsors are required at a ratio of 1 for every 3 juniors under the age of 18  
while at Camp Perry. **You will need to arrange for a sponsor.**
